

## **Bi-Weekly Newsletter**

Issue No. 3, April 28<sup>th</sup>, 2022

### **Intent:**

A concern that continues to surface amongst the public is the lack of communication between government and the members of the community in which that body of government operates. Open communication, or lack thereof, between elected officials and the citizens not only contributes to speculation and misinformation on issues, but also increases the divide and distrust between government and the people that the governing body serves. The time for correcting this issue is long overdue.

This newsletter offers a fact-based and bipartisan exchange of information in effort to assist the people of the community with staying up-to-date and informed on the issues concerning Saugerties. In addition to social media accounts, local bulletins, and the town website, this will be another resource for people to reference to better inform themselves on what has happened, what is happening, what will be happening, and information regarding upcoming events. The idea is that this resource outlines the most pressing issues relating to Saugerties. However, all other issues can and will be reported on based on the demand and feedback from the community.

### **Short Term Rentals:**

**(Original Material)** On Saturday March 12<sup>th</sup>, from 9:00am-12:00pm, the Town Board hosted a workshop at Town Hall regarding short term rentals (STRs). Present at this meeting were all Town Board members, the Saugerties Town Clerk, the Town Planner, a representative from the Comprehensive Planning Committee, the town attorney, the Building Inspector, and a handful of people from the public. This meeting was also offered online, and several people from the community

attended virtually as well.

The purpose of this special meeting was to collectively determine the best way to move forward, whether that be tackling this issue using special use permits (SUPs) or by adopting a local law specific to STRs. After approximately three hours of open discussion, the Town Board opted to move forward with Town of Saugerties Short Term Rental Law Draft. This consensus was reached on the basis that board felt that this course of action was the best way to support both the members of the community that have concerns about the operations of STRs, as well as those who participate and operate STRs.

Once the review of the draft language is completed, the public can expect a public hearing regarding STRs and the proposed law. At this time, a public hearing date has not been confirmed, but that date will be shared once it has been confirmed. Please check the town website, Facebook, or refer to upcoming versions of this newsletter for that designated public hearing date.

**(Update, 4/12/22)** During the previous Town Board meeting on 4/6/2022, the Town Board passed a motion to set public hearing dates regarding Local Law, adding Chapter 194, Short Term Rentals, amending Chapter 245 of the zoning code, on the following dates:

- Wednesday, 4/20/22, 6:00pm
- Wednesday, 5/18/22, 6:00pm

**(Update, 4/28/2022)** During the public hearing regarding Short Term Rentals, held on 4/20/2022, several members of the community spoke. Speakers represented a balanced mixture of STR owners/operators, small business owners, and concerned citizens. Key points made during the public hearing consisted of the following: clearly defining the inspection process and fines/fees associated with that process; reconsideration from the Town Board regarding a STR cap; further restrictions on non-owner occupied STRs; registration process; point of contact system/property manager availability in the event of an emergency; addressing outside big businesses buying/developing houses and large parcels for the sole purpose of STR operations.

The second public hearing regarding the proposed STR law for The Town of Saugerties will be held on Wednesday, 5/18/2022, at 6:00pm, at the Greco Senior Center. The regular scheduled Town Board meeting will immediately follow.

### **Zoning:**

Prior to the scheduled Town Board meeting on April 20<sup>th</sup>, a public hearing was held regarding zoning (“amendment to industrial and business uses” Local Law enacting zoning amendments to Chapter 245). Several business owners and citizens took the time to share their concerns with these proposed zoning changes. The highlights of the public comments were stronger and more precise language/definitions; impacts of future marijuana establishes as they relate to zoning changes; increased setback distances.

There will be a second public hearing regarding zoning on Wednesday, 5/18/2022, at 5:30pm at the Greco Senior Center. The public hearing regarding STRs and the regular scheduled Town Board meeting will immediately follow.

### **Harvester:**

Currently, the Village of Saugerties and the Town of Saugerties work in conjunction with each other to operate the harvester. The purpose of the harvester to collect the milfoil and water chestnuts at the Saugerties Beach area, and along

the Esopus Creek. This is done with goals of making the Beach area and the Esopus Creek more aesthetically pleasing, as well as safer for swimmer and kayakers. Typically, the harvester operates from the beginning of May until October.

Last year, the harvester and the employees operating the harvester, collected nearly 120 tons of milfoil from along the Creek and Saugerties Beach. Currently, it is the intent of the Village of Saugerties to begin operating the harvester by the second week of May. The plan is to have the harvester functioning 3-4 days per week, at 8 hours per day. Preliminary discussions have begun regarding acquiring a second harvester. This would ultimately allow for more effective use and strategic positioning of the harvester. Currently, the Village and Town are in search of another part time operator for the harvester. Job details include:

### **Saugerties Dog Park:**

During the Town Board meeting on 4/6/22, it was brought to the attention of the residents in attendance, both in person and virtually, that the Town of Saugerties has begun preliminary discussions regarding the creation of a dog park. At this time, there appears to be a private citizen (name is being kept confidential at this time) who is interested in providing the Town of Saugerties with a significant amount of funding for this project.

At this time, there also has been a potential location designated for this project. This location will be made available once it has been confirmed. However, the Town Board is confident that this location will meet the needs of the residents who will utilize the area, as well as provide privacy and the seclusion necessary to ensure the dog park will not be a nuisance of any kind.

Other details such as fees, cleanliness, assuring pet/owner safety, etc. will be provided once those discussions are held in further depth. Please stay tuned for further information and opportunities to discuss suggestions and/or concerns at upcoming Town Board meetings.


